ORDINANCE NO. 2003.01
AMENDMENT No. 1 TO ORDINANCE NO. 1903.01.02

AN ORDINANCE ADOPTING AMENDMENT No. 1 TO THE ANNUAL BUDGET OF THE CITY OF SAN ELIZARIO FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2019 AND ENDING SEPTEMBER 30, 2020; PROVIDING FOR THE REDUCTION OF CITY COUNCIL STIPENDS DURING THE PUBLIC HEALTH EMERGENCY; PROVIDING FOR THE FOLLOWING: FINDINGS OF FACT, REPEALER AND SEVERABILITY, AND EFFECTIVE DATE.

RECITALS

- WHEREAS, by Ordinance No. 1903.01.02, the City of San Elizario ("City") adopted its Annual Budget for Fiscal Year ("FY") 2019-2020; and
- WHEREAS, since adoption of the budget, the City needs to make revisions to the budget to reduce the amount budgeted for the monthly stipends for the Alderspersons during the health emergency declared in the City due to the COVID-19 pandemic, which has reduced the number of City Council meetings; and
- WHEREAS, the amount of the stipend is based on the amount budgeted for such purpose and accordingly, it is necessary to amend the budget to reduce the amount of the stipend budgeted and then paid; and
- WHEREAS, in the best interest of prudent budgeting, the City Council desires to amend the City's Annual Budget to reflect such reduction in FY 2019-2020; and
- WHEREAS, the City Council has authorization pursuant to Texas Local Government Code Section 102.010 to amend its budget; and

WHEREAS, upon passage, the City Clerk shall provide a copy of this Ordinance and budget amendment to the El Paso County Clerk as required by Section 102.009(d), Texas Local Government Code.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of San Elizario:

ARTICLE I. FINDINGS OF FACT

The foregoing recitals are adopted as facts and are incorporated fully herein.

ARTICLE II. BUDGET AMENDMENT

- 1) The City Council hereby amends and approves the following amendment to the municipal budget for fiscal year 2019-2020, and authorizes the City Administrator or her designee to determine and document the appropriate reductions as follows: To reduce the amount budgeted for each of the below items under Decrease Expenses by \$185 for each month in which the public health emergency declared in Ordinance No. 2007.01.02 of the City of San Elizario is in effect, beginning with the City pay period beginning April 20, 2020.

Decrease Expenses:

Aldersperson 1-Stipend per year	Reduce from \$4800 as stated above
Aldersperson 2-Stipend per year	Reduce from \$4800 as stated above
Aldersperson 3-Stipend per year	Reduce from \$4800 as stated above
Aldersperson 4-Stipend per year	Reduce from \$4800 as stated above
Aldersperson 5-Stipend per year	Reduce from \$4800 as stated above

Increase Expenses:

Special Projects	Increase revenue by the amounts of reductions as stated above

ARTICLE III. REPEALER AND SEVERABILITY

REPEALER: All ordinances, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.



This Ordinance shall be effective immediately upon passage.


