**RESOLUTION NO. 1711R.03B**

**A RESOLUTION AND ORDER BY THE CITY OF SAN ELIZARIO APPROVING THE IMPLEMENTATION OF THE INTERIM RATE ADJUSTMENT BY TEXAS GAS SERVICE; AND PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, Texas Gas Service Company ("TGS" or the "Company"), a division of ONE Gas, Inc., distributes natural gas within the city limits of the City of San Elizario ("City") pursuant to a franchise granted to ONE Gas, Inc. by the City, and is a gas utility; and

WHEREAS, pursuant to Texas Utilities Code Section 103.001, the City has exclusive original jurisdiction over the rates, operations, and services of TGS within the City; and

WHEREAS, pursuant to Texas Utilities Code Section 104.301, the Gas Reliability Infrastructure Program ("GRIP"), TGS filed on March 15, 2017 with the City and with the Texas Railroad Commission ("RRC") in Gas Utilities Docket No. 10612 its proposal to implement an interim rate adjustment to rates for gas service provided to customers of the City to be effective May 14, 2017; and

WHEREAS, the City Council of the City and the RRC suspended the proposed effective date for 45 days until June 28, 2017; and

WHEREAS, the RRC approved TGS' interim rate request in its "Interim Rate Adjustment Order" of June 6, 2017 whereby the requested rates were found to be properly processed and calculated in accordance with Section 104.301; and

WHEREAS, the reasonableness of TGS' investment will be reviewed in TGS' subsequent base rate case where all costs included in the GRIP filing will be subject to refund.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** by the City Council of San Elizario, Texas, that:


