A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF SAN ELIZARIO IN SUPPORT OF A TRANSITION PLAN PURSUANT TO THE AMERICANS WITH DISABILITIES ACT

## RECITALS

WHEREAS, the City of San Elizario ("City") is committed to making all of its facilities, programs, and services accessible to all residents, regardless of age or ability; and

WHEREAS, to achieve this goal, the City Council of the City finds that the creation of a transition plan under the Americans with Disabilities Act (ADA) will provide the guidance and direction necessary toward making city facilities, programs and services accessible; and

WHEREAS, the City Council recognizes that development of a plan begins with evaluation of the city's public services, programs, activities and existing physical facilities as they relate to accessibility; and

WHEREAS, the City Council supports involvement towards creating a plan to improve accessibility and equal access by fulfilling the requirements of the Americans with Disabilities Act.

## NOW, THEREFORE, BE IT RESOLVED by the City Council of San Elizario, Texas, that:

- Section 1. The foregoing recitals are adopted as facts and are incorporated fully herein.
- Section 2. The City of San Elizario hereby issues its commitment toward achieving ADA compliance of its facilities, programs and services to each resident of the City.
- Section 3. To initiate this goal, the City Council of the City authorizes city staff to work on those requirements necessary for the creation and establishment of an ADA Transition Plan including conducting a self-evaluation of the city's services, programs and practices.

- Section 4. City staff shall begin the evaluation process and draft a transition plan in cooperation with citizens, local disability advocates and other focus groups.
- Section 5. The City shall strive to create and place into effect a Transition Plan within one year after approval of this Resolution.
- Section 6. All resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters regulated, herein.
- Section 7. Should any of the clauses, sentences, paragraphs, sections or parts of this Resolution be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Resolution.
- Section 8. This Resolution shall be effective immediately upon passage and approval.
