# COUNCIL MEETING AMENDMENT RESOLUTION NO. 1602R.01

# A RESOLUTION AMENDING REGULATIONS REGARDING COUNCIL MEETINGS OF THE CITY COUNCIL OF THE CITY OF SAN ELIZARIO, TEXAS

WHEREAS, Texas Local Government Code Section 22.038 authorizes the City Council ("City Council") of the City of San Elizario ("City") to designate a time and place for city council meetings; and

**WHEREAS,** the City Council adopted a resolution in 2014, subsequently amended in 2015, designating such time and place for its meetings; and

**WHEREAS,** an update is necessary to reflect the cancellation of council meetings and the setting of regular and special called meetings.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of San Elizario, Texas, that:

#### I. FINDINGS OF FACT

The foregoing recitals are adopted as facts and incorporated fully herein.

#### 2. MEETING TIME AND LOCATION

Meetings of the City Council of the City of San Elizario will be held as follows:

- A. Regular meetings of the City Council shall be held on the second (2<sup>nd</sup>) and fourth (4<sup>th</sup>) Tuesday of each month. Special meetings and emergency meetings shall be called and set as necessary.
- B. The Mayor may call a special meeting on the Mayor's own motion and shall call a special meeting at the request of three alderpersons.
- C. A meeting of the City Council may be cancelled by the Mayor when deemed necessary or in the event of an emergency. Notice of cancellation of a regular meeting shall be

posted. Notice of cancellation of a special or emergency meeting shall be posted if prior notice of such meeting had been posted.

- D. The usual meeting time shall be 6:00 p.m.; however, the City Council may choose alternate times when deemed in the public interest based on the circumstances.
- E. The usual meeting place shall be the City Hall of the City of San Elizario located at 12710 Church Street in San Elizario, Texas; however, the City Council may choose alternate locations based on the circumstances and when deemed in the public interest.

## 3. REPEALER AND SEVERABILITY

REPEALER: All resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters regulated, herein.

SEVERABILITY: Should any of the clauses, sentences, paragraphs, sections or parts of this Resolution be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Resolution.

### 4. EFFECTIVE DATE

This resolution shall take effect immediately after passage and approval.
