# ORDINANCE NO. 1801.03A

#### LIMITED PUBLIC FORUM

AN ORDINANCE CREATING AND REGULATING THE CITY HALL PATIO AS A LIMITED PUBLIC FORUM FOR USE BY CITY ELECTION CANDIDATES DURING ELECTION TIME; PROVIDING FOR THE FOLLOWING: FINDINGS OF FACT, ADOPTION, ENACTMENT, REPEALER, SEVERABILITY, EFFECTIVE DATE, AND PROPER NOTICE AND MEETING.

- WHEREAS, the City of San Elizario ("City") is holding its first election since the inaugural City Council of San Elizario ("City Council") was elected in 2014; and
- WHEREAS, the City has experienced requests to use the City Hall Patio ("Patio") as the location for a public forum discussion between election candidates; and
- WHEREAS, it is in the interest of the City's citizens to be as informed as possible of the viewpoints and goals of the City's candidates for public office; and
- WHEREAS, the Supreme Court of the United States has acknowledged a municipality's authority to create a limited, or designated, public forum for expressive activities subject to strict scrutiny for any content-based speech restrictions; and
- WHEREAS, the City Council finds it in the interest of good governance to create a policy establishing the Patio as a limited public forum to be used only during elections, on a set date and for a set timeframe on such date, as a platform for election candidates; and
- WHEREAS, the City does not seek to regulate the content of the speech allowed during these set dates and times; and
- WHEREAS, pursuant to Texas Local Government Code Section 51.001, the City has general authority to adopt an ordinance or police regulation that is for the good

government, peace or order of the City and is necessary or proper for carrying out a power granted by law to the City; and

WHEREAS, the City Council finds that it is necessary and proper for the good government, peace, or order of the City to adopt an ordinance regulating the time and manner of use of the Patio as a limited public forum to be used by election candidates during election times.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of San Elizario:

#### ARTICLE I. FINDINGS OF FACT

The foregoing recitals are adopted as facts and are incorporated fully herein.

## ARTICLE II. ADOPTION AND ENACTMENT

The City Council hereby adopts and enacts the Ordinance regarding "Limited Public Forum Policy," attached hereto as "Attachment A" and incorporated fully herein this Ordinance for all intents and purposes.

#### ARTICLE III. REPEALER AND SEVERABILITY

REPEALER: All ordinances, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.

SEVERABILITY: Should any of the clauses, sentences, paragraphs, sections or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not construed to affect any other valid portion of this Ordinance.

#### ARTICLE IV. EFFECTIVE DATE

This Ordinance shall be effective immediately upon passage and publication.
