ORDINANCE NO. 1903.05

AN ORDINANCE AMENDING ORDINANCE NO. 1603.05, ADOPTING A FEE SCHEDULE FOR ZONING APPLICATIONS TO CREATE A REDUCED NEW FEE; AND PROVIDING FOR AN EFFECTIVE DATE.

RECITALS

- **WHEREAS**, the City Council ("City Council") of the City of San Elizario ("City") adopted a fee schedule for zoning applications on October 25, 2016; and
- WHEREAS, the City has determined that it is appropriate to adopt a separate, smaller fee for a zoning change request for reclassification that is submitted in conjunction with the filing of a plat; and
- **WHEREAS**, pursuant to Texas Local Government Code Section 51.001, the City has general authority to adopt an ordinance that is for the good government, peace or order of the City and is necessary or proper for carrying out a power granted by law to the City; and
- **WHEREAS**, pursuant to Chapter 102 of the Texas Local Government Code, the City has the specific authority to adopt a budget and provide for revenue and expenditures; and
- **WHEREAS**, the City Council finds that the new fee imposed by this Ordinance to be reasonable and necessary.

NOW, THEREFORE, BE IT ORDAINED by the City Council of San Elizario:

ARTICLE I. FINDINGS OF FACT

The foregoing recitals are adopted as facts and incorporated fully herein.

ARTICLE II. ADOPTION AND ENACTMENT

The City Council hereby adds the following fee to the "Fee Schedule: Zoning": Zoning Change Request – Classification (Rezoning) when submitted in conjunction with the filing of a plat (at or near the time of plat submission not to exceed 30 days following the filing or approval of a plat): \$50.00; and combines all fees into one document as set forth in Attachment A, attached hereto and incorporated fully herein for all intents and purposes.

ARTICLE III. REPEALER AND SEVERABILITY

REPEALER: All ordinances, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.

SEVERABILITY: Should any of the clauses, sentences, paragraphs, sections or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.

ARTICLE IV. EFFECTIVE DATE

This Ordinance shall be effective immediately upon passage.
