RESOLUTION NO. 2015R.20

A RESOLUTION TO ESTABLISH RELATING TO THE DAYS AND TIMES IN WHICH AN APPLICATION FOR A PLAT MAY BE SUBMITTED TO THE CITY PURSUANT TO SECTION 3.7.1 OF THE SUBDIVISION ORDINANCE OF THE CITY OF SAN ELIZARIO, ORDINANCE NO. 1915.20.

- WHEREAS, on March 13, 2020, the Governor of the State of Texas declared state of disaster and the President of the United States of America declared a national emergency in relation to COVID-19; and
- WHEREAS, by proclamation issued on March 16, 2020, the Mayor declared a local state of disaster for the City of San Elizario resulting from a public health emergency; and
- WHEREAS, this Resolution is necessary and appropriate due to the diversion of staff from their ordinary duties to response to the emergency, and potential closures of City Hall during the period of the emergency; and
- WHEREAS, Section 3.7.1 of the Subdivision Ordinance of the City of San Elizario, Ordinance No. 1915.20 allow the City Council by resolution, to restrict the days and times on which an application for a plat may be submitted to the City; and
- WHEREAS, this Resolution is now necessary and appropriate for the good government and good operations of the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of San Elizario, Texas, that:

1. FINDINGS OF FACT

The foregoing recitals are adopted as facts and incorporated fully herein.

2. DAYS AND TIMES ON WHICH AN APPLICATION MAY BE SUBMITTED

Resolution: City events and activities 2020 v.2

Due to the emergency and potential closures of City Hall during the duration of the declared emergency and state of disaster, the next day on which an application for a plat may be submitted is April 20, 2020. Provided however, should the emergency declaration and state of disaster still be in effect on that day or if City Hall is closed or closed to the public on that day, then no applications will be accepted. Thereafter, the first Monday of each following month shall be the date designated for the submission of an application for a plat, provided however, that the conditions under the proviso stated immediately above do not exist.

3. EXPIRATION DATE; AUTHORITY OF THE MAYOR

This Resolution shall expire upon the termination of the state of disaster or as may be directed by the Mayor, whichever is sooner. The Mayor is authorized to implement any directive that may be issued by the Governor of the State of Texas with regard to applications or timelines regarding land use ordinances or regulations of a city to include but not be limited to the Subdivision Ordinance, and such directives from the Mayor shall supersede this provision.

4. REPEALER AND SEVERABILITY

REPEALER: All resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters regulated, herein.

SEVERABILITY: Should any of the clauses, sentences, paragraphs, sections or parts of this Resolution be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Resolution.

5. EFFECTIVE DATE

This resolution shall take effect immediately after passage and approval.
