ORDINANCE NO. 1715.20

AN ORDINANCE REPEALING THE INTERLOCAL PUBLIC WORKS AGREEMENT WITH THE COUNTY OF EL PASO FOR PLATTING AND ENGINEERING SERVICES FOR SUBDIVISION PLAT APPLICATIONS.

- WHEREAS, in 2014, the City of San Elizario ("City") entered into an interlocal cooperation agreement ("Agreement") with the County of El Paso ("County") for public works services related to the regulation of subdivision plats in the City; and
- WHEREAS, in accordance with the Agreement, the City adopted the County's subdivision plat regulations, including those for variances and parks, to be effective and applicable within the City and its extraterritorial jurisdiction during the term of the Agreement; and
- WHEREAS, on July 11, 2017, the City adopted and approved the City of San Elizario Subdivision Ordinance to be effective July 25, 2017; and
- WHEREAS, as provided in the Agreement, the City has notified the County of termination of the Agreement as the City will be undertaking those tasks, as explained in Exhibit A; and
- WHEREAS, with the City's newly adopted and enacted subdivision ordinance, the County's subdivision plat regulations will no longer be necessary and of force and effect in the City.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of San Elizario:

ARTICLE I. FINDINGS OF FACT

The foregoing recitals are adopted as facts and incorporated fully herein.

ARTICLE II. REPEAL

The City Council of the City of San Elizario hereby repeals the Interlocal Public Works Agreement with the County of El Paso, for platting and engineering services within the City and its extraterritorial jurisdiction in the application of the County of El Paso Subdivision Plat Regulations revised December 13, 2005, as amended to include 2014 revisions regarding variances and parks.

ARTICLE III. REPEALER AND SEVERABILITY

REPEALER: All ordinances and resolutions, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.

SEVERABILITY: Should any of the clauses, sentences, paragraphs, sections or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.

ARTICLE IV. EFFECTIVE DATE

This Ordinance shall be effective immediately upon passage.
